PHLIPOT'S MARINE- OPEN BASS TOURNAMENT RULES

Interpretation of these rules shall be left exclusively to the tournament rules committee. The decision of the judges and tournament officials is final.

- 1) **SPORTSMANSHIP:** Competitors are expected to follow high standards of sportsmanship, courtesy, safety, and conservation. Boats are not permitted within reasonable casting distance of another competitor. Note: Dropping of anchor is only permitted when the competitor arrives first, Or when no other competitor is within 50 yards of the other. Anchored boats mean trolling motor up with the anchor rope In the water .
- 2) **LEGAL FISH:** Largemouth and Smallmouth Bass, minimum length of 12 inches or more on the longest straight with the mouth closed.
- 3) **SCORING:** Dead fish penalty of one (1) pound will be enforced per dead fish. Catch and release is strongly recommended. Short fish will be as follows: any fish not Measuring 12 inches with mouth closed will be called along With your big fish.
- 4) **TACKLE AND EQUIPMENT:** Artificial lures will be used only. No trolling will be allowed. Only one casting, spin casting, or rod and reel may be used at any time. All other Types are prohibited. No rods over 8ft in length are permitted...
- 5) **SAFETY:** Safe boating conduct must be observed at all times by all tournament competitors. Each competitor is required to wear a coat guard approved chest type life Preserver. This preserver must be worn at any time the Combustion engine is operating. The preserver must be Strapped, snapped, or zipped securely and maintained in This condition until the competitor reaches his fishing Location and his combustion engine is shut off. Violation Of this rule shall be reason for immediate disqualification.
- 6) **NO ALCOHOL:** Possession of alcoholic Beverages during the tournament hours Will be an immediate disqualification.
- 7) **DON'T KILL YOUR CATCH:** Each Competitor is expected to keep his/her bass alive. Alive/Dead decision will be made by tournament officials. No exceptions or disputes will be made.
- 8) **BIG FISH MUST BE ALIVE:** Entry for Big \$10.00 optional. 100% payback.
- 9) **NOTE:** No white colored fish, mangled, iced, or stiff fish allowed. Plus each competitor must abide by All Lake Rules and regulations. Anyone receiving a ticket will be disqualified.
- 10) **PROTEST:** Any competitor wishing to protest the score of the fellow competitor must do so before the tournament weigh-in starts. In the event the protest fee of \$500.00 will be Required to continue (the cost of a truth Detection test). The protest fee will be Refunded if the protest is deemed valid and The protested team will be immediately Disqualified. Only then can the award be Presented.
- 11) **CHECK IN:** Will be at the mouth of the canal at 3:00p.m. If you are late you will disqualified.
- 12) **Fish Limit:** Five (5) fish limit per boat, if Bring in more than 5, you will be disqualified.
